

Brexit FAQ's

It is getting closer to the time that Brexit is coming to the end of the transition period in a few months. We are starting to get questions from customers with regards to stock and our preparedness considering the changes ahead. We have put together a very basic FAQ's that may answer some of the questions you will undoubtedly have.

- Do we have a VAT number? Yes

- Do we have an EORI number? Yes
EORI Number GB245292209003
- Do we have a Deferment account? Yes
- Have you an appointed customs agent? Yes
- Have you assessed any Brexit impact on your supply chain? Yes
 - We have with the information as it remains currently. With negotiations ongoing impacts could be subject to change.
- Will you increase stockholding before 1st January 2021? Yes
 - Where possible during a global pandemic we have increased stock holding to minimise disruption to the supply chain. Most of our products are imported from outside of the EU so the import process so for most of our supply remains unchanged.
- Do you have commodity/Tariff codes for products? Yes,
 - we have tariff codes for all our imported items.
- We currently are not able to advise on any potential price changes in relation to tariff or duty implications post Brexit, due to no finalized EU withdrawal agreement being approved. As soon as more information is available, we will share this with you as a matter of urgency.

Operations and Logistics

- We have in place an arrangement with our export logistics partners a full customs declaration service to enable lead times to be kept to a minimum from a documentation perspective for all orders
